

Pursuant to Article 114, paragraph (6) of the Credit Institutions Act (Official Gazette 159/2013, 19/2015, 102/2015, 15/2018, 70/2019, 47/2020 and 146/2020), in conjunction with recital (75) of the preamble of Regulation (EU) No 575/2013 of the European Parliament and of the Council of 26 June 2013 on prudential requirements for credit institutions and investment firms and amending Regulation (EU) No 648/2012 (Official Journal L 176/2013), and pursuant to Article 43, paragraph (2), item (10) of the Act on the Croatian National Bank (Official Gazette 75/2008, 54/2013 and 47/2020), the Governor of the Croatian National Bank hereby issues the

**Decision on amendments to the Decision on the documentation to be enclosed with the application for permission to classify capital instruments as own funds instruments of credit institutions**

**Article 1**

In the Decision on the documentation to be enclosed with the application for permission to classify capital instruments as own funds instruments of credit institutions (Official Gazette 25/2018 and 145/2020), in Article 1, after paragraph (2), paragraphs (3) and (4) are added which read:

" (3) When carrying out its tasks referred to in Article 4, paragraph (1), item (d) of Regulation (EU) No 1024/2013, the European Central Bank shall have the powers of the Croatian National Bank referred to in the Act and Regulation (EU) No 575/2013.

(4) When deciding on the application for permission to classify capital instruments as own funds instruments of credit institutions, the Croatian National Bank and the European Central Bank shall carry out their tasks within a single supervisory mechanism in accordance with Article 6 of Regulation (EU) No 1024/2013."

**Article 2**

In Article 2, paragraph (1), item (1) is amended to read:

"1. 'Act' means the Credit Institutions Act (Official Gazette 159/2013, 19/2015, 102/2015, 15/2018, 70/2019, 47/2020 and 146/2020)."

In Article 2, paragraph (1), after item (5), item (6) is added which reads:

"6. 'Regulation (EU) No 1024/2013' means Council Regulation (EU) No 1024/2013 of 15 October 2013 conferring specific tasks on the European Central Bank concerning policies relating to the prudential supervision of credit institutions (OJ L 287/2013). "

**Article 3**

In Article 8, paragraph (2), the words "be considered" are replaced by the words "be" and the Croatian words translated as "a new capital instrument" are replaced by the same Croatian words in a different grammatical case, with no relevance to the English translation.

#### **Article 4**

In Article 9, the Croatian word translated as "decision" is replaced by another Croatian word, with no relevance to the English translation.

#### **Article 5**

In Article 10, paragraph (2), the Croatian words translated as "decision establishing" are replaced by other Croatian words, with no relevance to the English translation.

#### **Article 6**

This Decision shall be published in the Official Gazette and enter into force on the day the euro is introduced as the official currency in the Republic of Croatia.
