

**INFORMATION NOTICE ON PERSONAL DATA PROCESSING
FOR THE PURPOSES OF THE INVITATION FOR APPLICATIONS
FOR STUDENT INTERNSHIPS IN THE CNB**

Controller

The Croatian National Bank, Trg hrvatskih velikana 3, Zagreb (hereinafter: CNB) processes the personal data contained in the Application Form and the supporting documentation submitted by individuals – students in the context of disclosure and invitation for applications for student internships in the CNB in 2025, pursuant to the Decision on the conditions and criteria for student internships in the Croatian National Bank in 2025. The CNB receives documents comprising personal data directly from the individuals applying for internship under the invitation for applications by e-mail, post or personal delivery.

The purpose and legal basis for the processing

The CNB processes personal data for the purpose of selecting the individuals for student internships from the circle of applying candidates. The legal basis for personal data processing is the presumed consent of candidates as it is presumed that the candidates freely give their personal data for the purposes of applying for internship under the invitation for applications and participating in the selection process. Data processing is based on the legal basis laid down in Article 6, paragraph (1), item (a) of the General Data Protection Regulation¹.

The consent may be withdrawn at any time by sending a notice to: natjecajizastudente@hnb.hr (personal data processing performed by the CNB based on the consent prior to withdrawal remains lawful). If you withdraw your consent, the CNB shall delete stored data and your application will be considered cancelled.

Individuals who decide to apply for internship under the invitation for applications provide personal data to prove the existence of the conditions laid down in the invitation for applications and enable the CNB to verify whether a candidate meets the conditions for the application and the criteria relevant for the selection of the best-suited candidates. Applications of the applicants who fail to provide all the personal data in the required documentation will be considered incomplete and will not be considered by the CNB.

Recipients

The CNB will not transmit the personal data associated with the listed activities and purposes to a third party, i.e. it will use them exclusively for the purposes of the selection of students for student internship in the CNB.

Storing of personal data

The CNB will store the personal data obtained from the documentation received until the completion of the selection procedure under the invitation for applications *for student internship in the Croatian National Bank in 2025*, i.e. until the final selection of students for student internship in the CNB. The CNB will

delete the data of unselected individuals (both those provided on paper and electronically) as soon as the selection procedure is finalised.

The CNB will store and keep the personal data of the applicants selected for student internship in the CNB in accordance with the Archives and Archival Institutions Act² and the ordinance governing the processing and protection of archival and current records of the CNB for the purpose of recording selection process regularity and taking further actions in connection with student internships in the CNB for a period of two years following the end of all activities related to the invitation for applications for student internships.

Rights of persons whose data are processed

Pursuant to the conditions of the General Data Protection Regulation, the CNB will ensure the following rights in relation to your personal data processing:

- a) the right to information in the processing and access to personal data;
- b) the right to have the personal data rectified;
- c) the right to erasure (the right to be forgotten);
- d) the right to limitation of personal data processing; and
- e) the right to data transmission.

Data protection officer and supervisory authority

Any complaints regarding CNB actions in connection with your personal data processing should be addressed to the Croatian Personal Data Protection Agency (AZOP), Selska cesta 14, Zagreb, the supervisory authority responsible for personal data protection in the Republic of Croatia.
